SASS PROVIDES A COMPREHENSIVE RANGE OF SERVICES FOR SURVIVORS OF PAST AND RECENT SEXUAL ASSAULT, THEIR FAMILY MEMBERS, AND SIGNIFICANT OTHERS. SASS' SERVICES INCLUDE A 24-HOUR CRISIS AND SUPPORT LINE; 24-HOUR EMERGENCY LEGAL AND MEDICAL ADVOCACY; A DROP-IN ADVOCACY CENTER; CRIMINAL AND CIVIL LEGAL ADVOCACY, INCLUDING REFERRALS TO LEGAL SERVICE PROVIDERS FOR LEGAL ADVICE; SURVIVOR SUPPORT GROUPS; YOUTH ADVOCACY; AND OUTREACH AND COMMUNITY EDUCATION. AS ONE OF ONLY TWO STAND-ALONE SEXUAL ASSAULT SPECIFIC AGENCIES IN THE STATE OF OREGON, SASS FILLS AN ESSENTIAL ROLE. AS A RESULT OF WORKING SPECIFICALLY WITH SURVIVORS OF SEXUAL VIOLENCE, OUR STAFF HAVE IN-DEPTH EXPERTISE AND UNDERSTANDING OF THE UNIQUE ISSUES THEY FACE, PARTICULARLY THOSE WHO HAVE EXPERIENCED SEXUAL VIOLENCE OUTSIDE OF AN INTIMATE PARTNER RELATIONSHIP. WHILE OUR SERVICE AREA IS PRIMARILY LANE COUNTY, WE ARE FREQUENTLY CONTACTED BY SURVIVORS FROM THROUGHOUT THE STATE AND IN OTHER REGIONS OF THE COUNTRY WHO MAY FEEL THAT THE SERVICES IN THEIR LOCAL COMMUNITY ARE NOT APPROPRIATE FOR THEM.

IN 2022, SASS SERVED 1191 INDIVIDUALS ACROSS A TOTAL OF 2032 CLIENT CONTACTS. OF THE 2032 CONTACTS, APPROXIMATELY 839 WERE NEW TO SASS SERVICES. DURING THE SAME PERIOD, SASS RESPONDED TO 1147 CALLS TO OUR 24/7 HOTLINE, HAD 221 UNIQUE SUPPORT GROUP PARTICIPANTS (ACCOUNTING FOR 570 DUPLICATE CONTACTS), PROVIDED EMERGENCY MEDICAL ADVOCACY 179 TIMES, ACCOMPANIED 11 SURVIVORS TO MAKE A POLICE REPORT, AND ACCOMPANIED 2 SURVIVORS AT COURT PROCEEDINGS. THESE NUMBERS REFLECT A RETURN TO THE NEW NORMAL OF POST-ACUTE COVID PANDEMIC. DURING THIS YEAR, STAFF RETURNED TO THE OFFICE FULL TIME AND RESUMED PROVIDING IN-PERSON CLIENT SERVICES WHILE ALSO CONTINUING TO OFFER EXPANDED VIRTUAL SERVICES.

SASS OPERATES FROM AN EMPOWERMENT-BASED, SURVIVOR-CENTERED PHILOSOPHY; WE BELIEVE EVERY SURVIVOR HAS THE RIGHT AND ABILITY TO MAKE THEIR OWN CHOICES AND DECISIONS AND THAT THOSE DECISIONS DEFINE OUR ROLE AND LEVEL OF INVOLVEMENT. AS SASS ADVOCATES, OUR ROLE IS TO PROVIDE INFORMATION AND REFERRALS, AS APPROPRIATE AND AS REQUESTED BY THE SURVIVOR, NONJUDGMENTAL SUPPORT AND OPTIONS, AND TO RESPECT AND ADVOCATE FOR THE SURVIVOR'S CHOICES, RIGHTS, AND GOALS. SASS BELIEVES THAT OPPRESSION IS INEXTRICABLY LINKED TO SEXUAL VIOLENCE AND CREATES A CULTURE IN WHICH SEXUAL VIOLENCE IS MINIMIZED, DISMISSED, NORMALIZED AND GLAMORIZED. TO THAT END, SASS STAFF ACTIVELY ENGAGE COMMUNITY PARTNERS AND FELLOW RESPONDERS TO IMPROVE THE SYSTEM RESPONSE TO SEXUAL VIOLENCE THROUGH INCREASED PROJECT PARTNERSHIPS, COLLABORATIONS, AND AGENCY CROSS TRAINING.
