AS ONE OF ONLY TWO STAND-ALONE SEXUAL ASSAULT SPECIFIC AGENCIES IN THE STATE OF OREGON, SASS FILLS AN ESSENTIAL ROLE. AS A RESULT OF WORKING SPECIFICALLY WITH SURVIVORS OF SEXUAL VIOLENCE, OUR STAFF HAVE IN-DEPTH EXPERTISE AND UNDERSTANDING OF THE UNIQUE ISSUES THEY FACE, PARTICULARLY THOSE WHO HAVE EXPERIENCED SEXUAL VIOLENCE OUTSIDE OF AN INTIMATE PARTNER RELATIONSHIP.
